1 インストール

Sieve パッケージはあなたの Emacs の版に付属していて、すぐに使えるようになっているはずです。

そうっていないのであれば、このパッケージを手作業で設定するために、以下のコマンドを ~/.emacs ファイルに書き込んでください:

2 Sieve モード

Sieve モードは、構文に基づいたインデント、font-lock のサポート、および Sieve スクリプトを楽に編集できるようにするためのその他の便利な機能を提供します。

このメジャーモードに切り替えるには `M-x sieve-mode` を使ってください。このコマンドは `sieve-mode-hook` で与えられたフックを実行します。

Sieve モードは `c-mode` から派生していて、コメントの構文以外はとても似ています。インデントをカスタマイズする変数があるのと同様に、キーマップ(`sieve-mode-map`) は `c-mode` のものを受け継ぎます。Sieve モードは専用の略語表(`sieve-mode-abbrev-table`) と構文テーブル(`sieve-mode-syntax-table`) を持っています。

編集に役立つ関数に加えて、Sieve モードには Sieve スクリプトを遠隔管理するためのキー設定もあります。See Chapter 3 [Managing Sieve], p. 3.

C-c RET 「Sieve-管理」プロトコル(Manage Sieve protocol) を使って、遠隔サーバーに接続します。

C-c C-1 現在接続しているサーバーに Sieve スクリプトをアップロードします。

3 Sieve の管理

「Sieve-管理」は、遠隔サーバーにある Sieve スクリプトを表示するために使われる特別なモードです。それは `M-x sieve-manage` RET で起動し、そのサーバーにおけるユーザー名と、必要な場合には資格証明書(credentials) の入力を求めます。

サーバーとの接続に成功すると、「Sieve-管理」バッファには以下のようなものが表示されます:

スクリプトの一つが強調表示され、標準のポイント移動コマンド(UP, DOWN など) でリスト内を移動することができます。

以下のコマンドが「Sieve-管理」バッファで利用可能です:

- m* 現在の強調表示されたスクリプトを活性化します。
- u* 現在の強調表示されたスクリプトを不活性化します。
- C-M-?* すべてのスクリプトを不活性化します。
- r* 現在の強調表示されたスクリプトを取り除きます。
- RET
- mouse-2*
- f* サーバーバッファを隠して、現在の強調表示されたスクリプトを Sieve モード(see Chapter 2 [Sieve Mode], p. 2) で編集するための新しいバッファにダウンロードします。
- o* Sieve モード(see Chapter 2 [Sieve Mode], p. 2) で編集するために、現在の強調表示されたスクリプトを含んでいる新しいバッファを、別ウィンドウで作成します。
- q* 接続を切らずに「Sieve-管理」バッファを隠します。
- ?*
- h* ミニバッファにヘルプを表示します。
- g* 現在接続しているサーバーにあるスクリプトのリストをリフレッシュします。現在の Sieve バッファの内容を更新します。
- Q* 「Sieve-管理」を終了して接続を切ります。

4 例

Sieve を熟知していないなら、この章にほんの少しだけあるコードの断片を利用すれば良いでしょう。Sieve 言語でゼロから規則を書くことがもっと快適に感じられるようになるまでは、それらをカット&ペーストして好きなように変更してください。

以下の完全な Sieve スクリプトは、合致する‘Sender:’ヘッダーを持つすべてのメッセージを、指定されたメールボックスに格納します。多くのメーリングリストがこの形式を使っています。最初の行は Sieve サーバーが確実に `fileinto` コマンドを理解できるようにするためのものです。

少数のメーリングリストは‘Sender:’ヘッダーを使いませんが、ある別のヘッダーに独特の識別子があります。以下のスクリプトは完全ではなく、すでに `fileinto` が読み込まれていることを仮定しています。

if header :contains "Delivered-To" "auc-tex@sunsite.dk" {
    fileinto "INBOX.auc-tex";
}
```

最後は、どんな独特の識別子も持っていない絶望的なメーリングリストのために、‘To:’と‘Cc’ヘッダーにおける合致を強いられる例です。前のものと同様に、この断片は `fileinto` が読み込まれていることを仮定しています。

5 「Sieve-管理」の API

`sieve-manage.el` ライブラリーにはMANAGESIEVE プロトコルでサーバーと話すための、低階層の関数群があります。

いくつかの、ユーザーが見ることができる変数があり、それらすべては`sieve` グループでカスタマイズすることができます(*M-x customize-group RET sieve RET*):

`sieve-manage-default-port`

仕様するデフォルトのポートを設定します。提案されているポート番号は2000 です。

`sieve-manage-log`

非-`nil` だったら、やり取りしたプロトコルの結果が記録されるバッファ名 of 文字列でなければなりません(デバッグするときに使います)。

API の関数には以下のものがあります:

`sieve-manage-open`

「Sieve-管理」サーバーに接続し、他のすべての API で使うバッファを返します。

`sieve-manage-opened`

サーバーと接続しているか否かを検査します。

`sieve-manage-close`

サーバーとの接続を閉じます。

`sieve-manage-authenticate`

サーバーの認証を受けます。

`sieve-manage-capability`

サーバーがサポートしている機能のリストを返します。

`sieve-manage-listscripts`

サーバーにあるスクリプトを列挙します。

`sieve-manage-havespace`

与えられたサイズのスクリプトのための空きがあれば、非-`nil` を返します。

`sieve-manage-getscript`

サーバーからスクリプトをダウンロードします。

`sieve-manage-putscript`

サーバーにスクリプトをアップロードします。

`sieve-manage-setactive`

サーバーにあるどのスクリプトが活きているはずであることを示します。

0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document *free* in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or non-commercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of “copyleft”, which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. But this License is not limited to software manuals; it can be used for any textual work, regardless of subject matter or whether it is published as a printed book. We recommend this License principally for works whose purpose is instruction or reference.

1. APPLICABILITY AND DEFINITIONS

This License applies to any manual or other work, in any medium, that contains a notice placed by the copyright holder saying it can be distributed under the terms of this License. Such a notice grants a world-wide, royalty-free license, unlimited in duration, to use that work under the conditions stated herein. The “Document”, below, refers to any such manual or work. Any member of the public is a licensee, and is addressed as “you”. You accept the license if you copy, modify or distribute the work in a way requiring permission under copyright law.

A “Modified Version” of the Document means any work containing the Document or a portion of it, either copied verbatim, or with modifications and/or translated into another language.

A “Secondary Section” is a named appendix or a front-matter section of the Document that deals exclusively with the relationship of the publishers or authors of the Document to the Document’s overall subject (or to related matters) and contains nothing that could fall directly within that overall subject. (Thus, if the Document is in part a textbook of mathematics, a Secondary Section may not explain any mathematics.) The relationship could be a matter of historical connection with the subject or with related matters, or of legal, commercial, philosophical, ethical or political position regarding them.

The “Invariant Sections” are certain Secondary Sections whose titles are designated, as being those of Invariant Sections, in the notice that says that the Document is released under this License. If a section does not fit the above definition of Secondary then it is not allowed to be designated as Invariant. The Document may contain zero Invariant Sections. If the Document does not identify any Invariant Sections then there are none.

Examples of transparent image formats include PNG, XCF and JPG. Opaque formats include proprietary formats that can be read and edited only by proprietary word processors, SGML or XML for which the DTD and/or processing tools are not generally available, and the machine-generated HTML, PostScript or PDF produced by some word processors for output purposes only.

The “Title Page” means, for a printed book, the title page itself, plus such following pages as are needed to hold, legibly, the material this License requires to appear in the title page. For works in formats which do not have any title page as such, “Title Page” means the text near the most prominent appearance of the work’s title, preceding the beginning of the body of the text.

The “publisher” means any person or entity that distributes copies of the Document to the public.

A section “Entitled XYZ” means a named subunit of the Document whose title either is precisely XYZ or contains XYZ in parentheses following text that translates XYZ in another language. (Here XYZ stands for a specific section name mentioned below, such as “Acknowledgements”, “Dedications”, “Endorsements”, or “History”.) To “Preserve the Title” of such a section when you modify the Document means that it remains a section “Entitled XYZ” according to this definition.

The Document may include Warranty Disclaimers next to the notice which states that this License applies to the Document. 2. VERBATIM COPYING

4. MODIFICATIONS

- H. Include an unaltered copy of this License.
- I. Preserve the section Entitled "History", Preserve its Title, and add to it an item stating at least the title, year, new authors, and publisher of the Modified Version as given on the Title Page. If there is no section Entitled "History" in the Document, create one stating the title, year, authors, and publisher of the Document as given on its Title Page, then add an item describing the Modified Version as stated in the previous sentence.
- J. - O. Preserve any Warranty Disclaimers.

If the Modified Version includes new front-matter sections or appendices that qualify as Secondary Sections and contain no material copied from the Document, you may at

your option designate some or all of these sections as invariant. To do this, add their titles to the list of Invariant Sections in the Modified Version's license notice. These titles must be distinct from any other section titles.

If you have Invariant Sections without Cover Texts, or some other combination of the three, merge those two alternatives to suit the situation.
